A Science Diplomacy Approach for Belgium?!



Thursday, 1 December 2016 9:00 - 14:00 Royal Library, Boulevard de l'Empereur 4, Brussels We live in a quickly evolving global landscape characterised by a digital knowledge society and faced with several global challenges, which can only be tackled through international cooperation. A collective and structured effort is needed, with a certain degree of urgency, to uphold the position of Belgium as a significant player on the global map, while taking into account our decentralised institutional landscape in which different entities can work by building on complementarities and by mutually reinforcing each other.

Science Diplomacy based on different types of interactions among the scientific community and the policy and decision-making world becomes increasingly a part of a broader contemporary public diplomacy (more hybrid, more multi-actor).

At the European level, Science Diplomacy has clearly become a high priority on the political agenda. The European External Action Service (EEAS) and the European Commission's DG Research and Innovation are working towards the development of a common approach to this external dimension of science and innovation policies. In a recent note, Commissioner for Research, Science and Innovation Carlos Moedas declared that science diplomacy is becoming an increasingly important element of the EU's foreign policy and he committed to fostering the development of EU science diplomacy.

Several Belgian entities have similar interests as well as questions with regard to the roles of different actors and way of investing in and framing of "Science (and innovation) Diplomacy". Our common challenge is to define how to best link scientific and innovation cooperation with diplomacy and political influence in order to tackle global changes, to promote knowledge and our country and to improve our international relations and cooperation. All the players involved (autonomous actors from the R&D&I performing community, policy-makers and private sector) may benefit from exchanging experiences and best practices and aim to come to a common understanding and drawing up of a (joint) win-win strategic approach for the future.



The Belgian Science Policy Office (www.belspo.be) is the federal administration responsible for the preparation and implementation of R&D programmes in several fields. It includes 10 Federal Scientific Institutions, represents the Belgian federal authority in various committees and consulting bodies and co-ordinates research activities at an international and national level.

The ideal mix between economy, science and innovation to bring Flanders to the top of European regions: that's what we're looking for. The Department of Economy, Science and Innovation (EWI) seeks to achieve this



through the preparation, monitoring and evaluation of policy. Working in a climate of openness and cooperation, we tailor our ideas to those of our partners in our own policy area and with the other policy areas.



Wallonie-Bruxelles International (WBI) is the public body in charge of international relations for Wallonia and the French-speaking Community of Belgium. The relations with foreign partners proceed on a bilateral (ability to sign treaties) or

multilateral level, e.g. with representations within international organizations such as the OECD, the European institutions and specialized organizations of the UNO (ILO, UNIDO, UNESCO, etc.).

The Institute for European Studies (IES) at the Vrije Universiteit Brussel (VUB) is an academic Jean Monnet Centre of Excellence and a policy think tank that focuses on the European Union in an international setting.



The Institute advances academic education and research in various disciplines, and provides services to policy-makers, scholars, stakeholders and the general public. The IES acts as the coordinator of the Horizon 2020 project EL-CSID.

It will also propose a set of recommendations for the way forward in formulating a Science Diplomacy approach for Belgium.

 - What are the available science advisory mechanisms?

 - Which structures could help bring diplomacy and science together?
- 3. Science for diplomacy
 - Which scientific areas are most relevant to diplomatic relations?
 - How can scientists take up diplomatic roles?
 - Which structures could help bring science and diplomacy together to reinforce each other?
- 4 Horizontal issues
 - How to determine which geographical and topical issues are the most relevant to address with limited resources?
 - How should the above mentioned mechanisms be monitored or evaluated on results or impact and, if needed improved?

Johan HANSSENS

Secretary-general of the Department of Economy, Science & Innovation



Johan Hanssens has been Secretary-general of the Department of Economy, Science & Innovation within the Flemish administration since 1 December 2015 and is president of the CIS-CFS which is the intraBelgian administrative science and innovation concertation platform.

In the past, he was (deputy) Head of Office to former minister for Economy Patricia Ceysens and to former Vice-Minister-President of the Government of Flanders Annemie Turtelboom. In the latter function he was competent for economy, innovation, work matters and Flanders foreign affairs. He holds master's degrees in economic sciences and law.

Johan Hanssens strongly believes in cooperation as an answer to the huge societal challenges. According to him "3 processes are key in innovation-driven economies such as the Flemish economy, viz. entrepreneurship, innovation and internationalisation. Systematic feedback and coordination and dynamic interaction are essential to achieve sustainable solutions throughout these processes".



Kostas GLINOS

DG Research & Innovation European Commission

Kostas Glinos has been with the European Commission since 1992. He leads the "Strategy, EFTA and enlargement countries, Russia, Asia and Pacific" unit within the directorate in charge of International Cooperation of the Directorate General for Research and Innovation.

Before that he was in charge of the e-Infrastructures unit of the Directorate General for Information Society and Media from January 2009 to December 2013. From 2003 to 2008 he was Head of the Embedded Systems and Control unit and interim Executive Director of the ARTEMIS Joint Undertaking.

Previously he was deputy head of Future and Emerging Technologies. Before joining the Commission Kostas worked with multinational companies and research institutes in the U.S., Greece and Belgium.

He holds a diploma in Chemical Engineering from the University of Thessaloniki, a PhD from the University of Massachusetts and a MBA in investment management from Drexel University.

Pierre-Bruno Ruffini, former President at the University of Le Havre, is currently Professor at the Faculty of International Affairs at this university. From 2007 until 2013, he was a Science and Technology advisor within the French diplomatic network.

He is the author of 'Science et diplomatie – Une nouvelle dimension des relations internationales', which was published in 2015 by the Editions du Cygne (Paris). The English version will soon be published by Springer.



Pro. Dr. Zehra SAYERS

Director, Foundation Development Program, Sabanci University and Chair, SESAME Scientific Advisory Committee

Dr. Zehra Sayers is a molecular biophysicist working on structure-function relationships in biological molecules. She is a founding member of the Genetics, Molecular Biology and Bioengineering program at Sabanci University in Istanbul. She is also the Director of the Foundations Development Program coordinating core curriculum courses at Sabanci.

Since 2002 Dr. Sayers has been the Chair of the Scientific Advisory Committee of the SESAME (Synchrotron-light for Experimental Science and Applications in the Middle East) project in Jordan. SESAME aims to foster scientific excellence in the Middle East and in the neighboring countries, and to develop better understanding through scientific collaboration among people of different cultures and political systems. Members of SESAME are currently Bahrain, Cyprus, Egypt, Iran, Israel, Jordan, Pakistan, the Palestinian Authority and Turkey.

Dr. Sayers obtained a BSc in Physics from Bogazici University in Istanbul and completed her PhD at Guy's Hospital Medical School, University of London. She worked as a staff scientist at EMBL Hamburg conducting pioneering work in use of synchrotron radiation for structural studies of cytoskeletal proteins and chromatin. After returning to Turkey her main area of research is on signaling proteins and metal binding proteins in plants. She pioneered structural investigations in Turkey and was instrumental in training young scientists in this field

Dr. Guillermo Orts-Gil is the Scientific Delegate of the Spanish Foundation for Science and Technology (FECYT) in Germany, depending of the Spanish Ministry of Economy and Competitiveness, at the Embassy of Spain in Germany. Since 2015 he is also member of the "Berlin Science Attachés Circle".

After finishing his PhD in physical-chemistry at the Technical University in Berlin (TUB), he was nanotechnology project manager at the Federal Institute for Materials Research (BAM) in Germany and group leader at the Max Planck Society (MPG). During this time, he also worked as a Head of Communications of the Society of Spanish Researchers in German (CERFA).

He has large experience in project management, starting in 2008 with the International Management program at the TUB. In the last years, he has been invited as a guest lecturer at the TUB and at The School of Management of UPF Barcelona. Moreover, from December 2016 on he will attend the Center for Cultural Diplomacy Studies in Berlin.



Dr. Luk VAN LANGENHOVE

Dr. Luk Van Langenhove is a Research Professor and the Scientific Coordinator of the EL-CSID project at the Institute for European Studies, Vrije Universiteit Brussel, and Senior Advisor European Strategy at the University of Warwick.

Previously, he was the Director at the United Nations University Institute on Comparative Regional Integration Studies (UNU-CRIS) in Bruges and the Representative of the UNU Rector at UNESCO in Paris.

He also worked as the Deputy Secretary-General at the Belgian Federal Ministry of Science Policy, Deputy Chief of Cabinet at the Belgian Federal Minister of Science Policy and as a researcher and lecturer at the Vrije Universiteit Brussel. Dr. Van Langenhove is a graduate of the Vrije Universiteit Brussel and received his Ph.D. in Psychology from the same university.

He has published widely on regional integration, social sciences theory, positioning theory and psychology. Recent books include People and Societies (Routledge, 2010), World-Regional Social Policy and Global Governance (with Deacon, Yeates and Macovei, Routledge, 2010).

Prof. Dr. Richard Higgott is a Research Professor at the Institute for European Studies and Distinguished Professor of Diplomacy at the Vrije Universiteit Brussel, and Emeritus Professor of International Political Economy at the University of Warwick. Prior to joining the IES, he held senior administrative appointments as Pro Vice Chancellor for Research at the University of Warwick and Vice Chancellor of Murdoch University in Australia.

He also held early career junior appointments at several universities including the University of Western Australia and the John F Kennedy School of Government at Harvard followed by appointments as Professor of International Politics and Public Policy at the Australian National University and Director of its Graduate Training Programme for the Australian Department of Foreign Affairs and Trade and Professor of Government at the University of Manchester.

He is the author and/or editor of 20 plus books and monographs and 120 plus peer reviewed book chapters and articles in major journals such as International Organization, Political Science Quarterly, International Political Science Review, International Affairs, International Journal, Review of International Studies, Review of International Political Economy, New Political Economy, International Relations, Politique Etrangère, International Politik, and others.



Frank MONTENY

Director-General of Research and Space of the federal science management at BELSPO

Frank Monteny (26 April 1963) is Director-General of Research and Space of the federal science management, BELSPO. He obtained his degree as Engineer in science and agricultural industries at the Vrije Universiteit Brussel. After his studies he worked as researcher at the same university, as project manager at the environmental study and advice bureau ERM, in diverse capacities at the federal science management and as coordinator European projects at the Vlaams Innovatie Agentschap (IWT).

He currently supervises the preparation and execution of several research programmes managed by BELSPO, including Belgium's participation in international space programmes and the coordination and monitoring activities of science policy affairs the department is involved in. He is sits on the management board of several federal scientific institutions.

Koen VERLAECKT

Secretary-General of the Flanders Department of Foreign Affairs (iV)

Koen Verlaeckt was born in 1966 in Dendermonde, Belgium. He obtained his university degree in history and his Ph.D. degree in archaeology, both at the University of Ghent, where he was active in archaeological research. Nationally and internationally, he published several books and articles, specializing in the archaeology of the Bronze Age (c. 2000-750 BC), both in Flanders (Belgium) and Denmark.

In 1997 he joined the Flemish Science and Innovation administration, first as a senior researcher in the Sciences Division, since 2003 as acting head of division of the Technology and Innovation Division. He was responsible for policy monitoring and policy preparation in various topics, ranging from basic research to bilateral international S&T co-operation. At European level, he was active as a programme committee member in the European Framework Programme for Research and Development, both for research infrastructures and the Marie Curie actions. He was also a member of the Steering Group Human Resources and Mobility and was closely involved with policy discussions preparing the Code of Conduct and the European Quality Charter for Researchers.From 1 March 2006 to 9 October 2007 Koen Verlaeckt served the Government of Flanders as Head of Cabinet and as senior advisor in charge of science and innovation policy.

On 21 April 2008 he was appointed by the Government of Flanders for a first 6-year mandate as Secretary General of the Flanders Department of Foreign Affairs. The Department has been entrusted with the preparation, evaluation and monitoring of Flemish governmental policy in the field of foreign affairs, development cooperation, foreign trade and tourism. Koen Verlaeckt started his second 6-year mandate as Secretary General on 21 April 2014.
